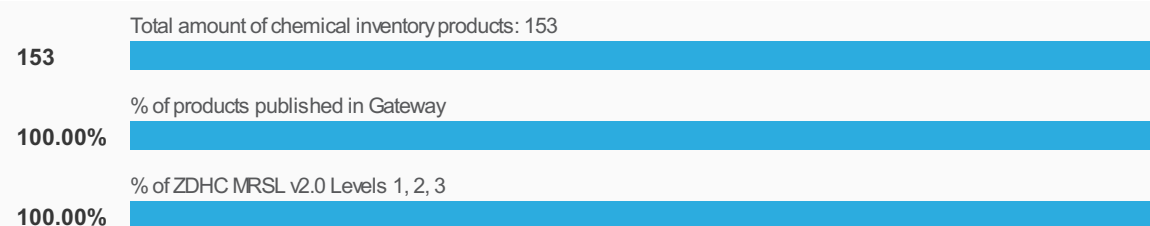

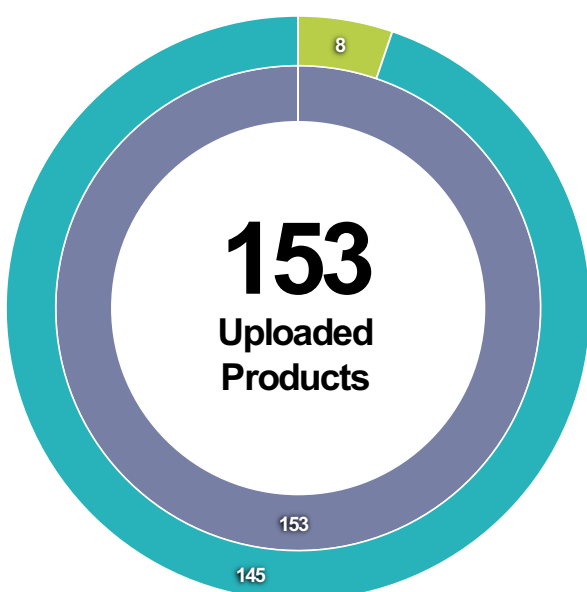
Performance InCheck Report - October 2021

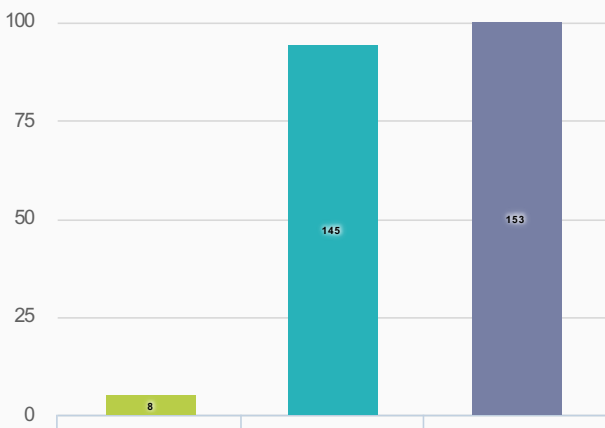
